1 Rules

1.1 The Race will be governed by the rules, as defined in the Racing Rules of Sailing (RRS) 2017 – 2020, the Prescriptions of Australian Sailing (AS), and the Special Regulations of AS - Addendum A - Category 6, and the Sailing Instructions (SI).

2 Conditions of Entry

2.1 Entries may be made by notifying the Sailing Committee of intention to compete.

2.2 Each vessel shall have public liability insurance, not less than A\$5 million.

2.3 By entering the owner/charterer agrees to be bound by the RRS, Notice of Race and the SI.

3 Divisions and Handicapping

3.1 All boats race in Division 1 using the performance handicap system and PDYC Seasonal Series handicaps.

6.1 Buoy races; windward/leeward or triangle sausage to be determined at race briefing.

6.2 The schedule of races may change depending on the forecast conditions.

7 Scoring

7.1 Three races are required to be completed to constitute a series.

7.2 Points scored count towards PDYC Club Championship.

8 Prizes

8.1 Prizes, to be announced at the presentation, will be given to 1st, 2nd and 3rd on corrected time in each race.

8.2 Presentation of prizes will follow conclusion of racing each day at Port Douglas Yacht Club.
